### Emanuel Lutheran Church Council Meeting- September 14, 2022

**Opening Devotions –** Pastor Todd spoke about Martin Luther's interpretation of the 8<sup>th</sup> commandment – You shall not bear false witness against your neighbor.

This at a base level means we should not tell lies about our neighbor. However, in Luther's Small Catechism he extends this and says it means not only should we not tell lies about our neighbor, but that we should defend them, and speak well of them, and explain their actions in the kindest way. This means that if we hear of someone doing something that we don't like, that we should give the person the benefit of the doubt. We should think – they may have a good reason for doing that. Until we know all the facts, we should assume the best about people. This is especially true for our brothers and sisters in the church.

#### Review and approve August Council Minutes - Approved unanimously.

#### Treasurer's report

• Financially we are doing pretty well, especially coming out of summer – a time when giving sometimes goes down. Many people are giving through automatic means Simply Giving and Givelify now and this really helps.

#### Christian Education -

- Confirmation and Sunday school kicked off last Sunday 9/11.
- Confirmation we have 6 students.
- We have teachers in place for Sunday school and confirmation.
- See the Christian Ed. Committee minutes for September for more information.

#### Finance

- Please submit budget requests to the Finance Committee by October 7<sup>th</sup>. The Finance Committee will begin working on the 2023 budget at the October meeting.
- Finance will be meeting with Sarah Groleau our Thrivent Representative in October.
- Financial Secretary job description
  - The Finance Committee put together a draft of a job description for Financial Secretary job.
  - Not everyone on the council received the description before the council meeting. The job description was read at the council meeting.
  - Danielle David is considering taking on this role. Danielle is already doing many of the items on the job description. Walter Phaneuf has stepped down from this role in July.
  - Council needs to approve the job description and add to the constitution's bylaws.
  - Question raised Who compares counter tally sheet with what has been deposited in the bank? This is something the Financial Secretary should do. Should this be added to the job description – Compare and verify that the counter tally sheets amount equals the amount deposited in the bank. Finance

Committee will discuss and possibly update the job description at their next meeting. Council will review at the October meeting.

#### Property

- See Property Committee report
- Joyful Noise requested replacing the rubber flooring in the big classroom with wood laminate. This is the \$30K floor that was put down several years ago. Property committee will not allow this. The rubber floor was selected for safety reasons.

### Worship and Music

- See Worship & Music Committee report.
- Blessing of Animals on Oct 2<sup>nd</sup> people will be invited to bring a picture of their favorite animal(s).
- Nancy Kennedy hasn't taken any days off yet. Is she planning on taking vacation. Finance is curious for budgeting purposes. We would need to pay for a substitute.

### **Church Picnic**

- Picnic planned for October 2<sup>nd</sup>.
- We have a Thrivent grant to help pay for bouncy house and food.
- Planning on having face painting, corn hole tournament.
- No rain date has been planned.
- Myron will be in charge of food.
- People from the neighborhood will be invited.
- Bruce will apply for a Thrivent grant for food for the Fall Bazaar in November.

### **Constitution Proposed Changes**

- Special congregational meeting Nov. 6<sup>th</sup> to consider adopting the required clauses from the 2019 ELCA model constitution.
- A new updated 2022 ELCA model constitution came out at the end of August. It was determined that it would be too rushed to try and consider these new changes at the 11/6 meeting. These will be considered at a future date.
- The congregation needs to be notified at least 30 days before the 11/6 meeting by October 7<sup>th</sup>. A letter will be sent to members that includes the comparison of Emanuel's constitution to what the constitution would look like if we adopt the required clauses from the ELCA model constitution. This comparison highlights the changes we will be considering. Ken Wieboldt will help in getting the mailing out.

### Contacting Members We Haven't Seen

- What is the status of calling the people we haven't seen in a while?
- The list of people was given to Kym, the office admin to call.
- Pr. Todd will follow up with Kym and get a status on who has been contacted.

### Youth Group

- Dina Andersen & Rebecca Nunez have agreed to be co-advisors of the youth group.
- A Youth Group Halloween party will be held on Saturday October 22<sup>nd</sup>.
- A list of about 80 youth connected to Emanuel was given to Myron.

### **Picture Copyrights**

- Emanuel received a letter from Pic Rights International. They enforce copy right laws for companies like Reuters news. Their letter included a photo that Emanuel used on its Facebook page. Pastor Todd copied the picture from the internet not realizing that it was from Reuters or copyrighted. The letter requested \$350 payment for use of the picture and threatened court action.
- After looking into this we believe that Pic Rights International is a legitimate company. There are lots of people on the internet that are not happy with them with stories similar to ours some with much bigger fees/fines.
- Pastor Todd has deleted this picture from our Facebook page. He also deleted any other picture that might have been copyrighted. In the future Pastor Todd will be much more careful about using pictures from the internet.
- Carol Johnson is reaching out to Pic Rights International to see if she can get the fee to be dropped or lowered.

### Jane Wahl Gift Part 2

- Emanuel was contacted by Jane Wahl's account. They told us that we will be receiving another distribution of \$60,000 from Jane's estate. Thank you Jane!
- We will consider how best to use this money at the October council meeting. Use the next month to think about how God would want Emanuel to use the money. Speak with other people in the congregation and get people's thoughts and ideas.

### **Council replacement for Walter Phaneuf**

• Should we find a replacement for Walter on the council? Yes, if there's anyone who would like to serve on council for the remainder of the year, they would be enthusiastically welcomed.

### Is it Valid for the Council or Congregation to vote over Zoom?

- The question was raised whether or not it is valid for the council or congregation to vote over zoom. This September Council meeting was held over zoom because 4 members of the council tested positive for COVID. It would have been difficult, perhaps not possible to get a quorum otherwise.
- Where in the constitution does it say voting over Zoom is not allowed? Look at C17.02 a and b

\*C17.02.A proposed amendment to this constitution shall:

- a. be approved at a legally called meeting according to this constitution by a majority vote of those present and voting;
- b. be ratified without change at the next annual meeting by a twothirds majority vote of those present and voting; and
- It states "by a majority of those present and voting" Are people attending over Zoom "present"?
- Under Congregational Meetings the constitution says C10.07 that we need to follow Robert's Rules

C10.07. Robert's Rules of Order, latest edition, shall govern parliamentary procedure of all meetings of this congregation.

- Myron says Robert's Rules only allows in person voting. What does the latest edition of Robert's Rules say about voting over Zoom?
- During the COVID pandemic the council decided that we would meet and vote over Zoom. We did this for almost 2 years with council meetings. Two congregational meetings were held both with people in-person and people over Zoom. Much care was taken to include people and keep people safe.
- Myron requests under Emanuel's constitution clause C15.11 a meeting with the synod Consultation Committee to get their ruling on whether or not Zoom voting is allowed or not.
  - \*C15.11.When there is disagreement among factions within this congregation on a substantive issue that cannot be resolved by the parties, members of this congregation shall have access to the synodical bishop for consultation after informing the chair of the Congregation Council of their intent. If the consultation fails to resolve the issue(s), the Consultation Committee of the synod shall consider the matter. If the Consultation Committee of the synod shall fail to resolve the issue(s), the matter shall be referred to the Synod Council, whose decision shall be final.
- Pr. Todd will reach out to our synod representative Kim Bergstrand and request this.

# Evangelical Lutheran Church in America

Emanuel is a member of the Evangelical Lutheran Church of America - the ELCA.

Emanuel is governed by a constitution. The ELCA provides a model constitution for all its members as a guide. Some provisions of the model constitution are required to be followed by all congregations who are members of the ELCA. Specifically:

\*PREAMBLE Chapter 2. CONFESSION OF FAITH \*C2.01., \*C2.02., \*C2.03., \*C2.04., \*C2.05., \*C2.06. and \*C2.07. Chapter 3. NATURE OF THE CHURCH \*C3.01., \*C3.02., \*C3.03., \*C3.04. and \*C3.05. Chapter 4. STATEMENT OF PURPOSE \*C4.01., \*C4.02., \*C4.03., \*C4.04., \*C4.05. and \*C4.06. Chapter 5. POWERS OF THE CONGREGATION \*C5.01., \*C5.02., \*C5.03. and \*C5.04. Chapter 6. CHURCH AFFILIATION \*C6.01., \*C6.02., \*C6.03., \*C6.04., \*C6.05., \*C6.06. and \*C6.07. Chapter 7. PROPERTY OWNERSHIP \*C7.01., \*C7.02., \*C7.03. and \*C7.04. Chapter 8. MEMBERSHIP \*C8.01., \*C8.02., \*C8.03., \*C8.04. and \*C8.05. Chapter 9. ROSTERED MINISTER \*C9.01., \*C9.02., \*C9.03., \*C9.04., \*C9.05., \*C9.06., \*C9.07., \*C9.08., \*C9.09., \*C9.11., \*C9.12., \*C9.13., \*C9.14., \*C9.21., \*C9.22., \*C9.23., \*C9.24., \*C9.25., \*C9.26., \*C9.27., \*C9.28., \*C9.29. and \*C9.31. Chapter 15. DISCIPLINE OF MEMBERS AND ADJUDICATION \*C15.01., \*C15.02., \*C15.03., \*C15.04., \*C15.05., \*C15.06., \*C15.07., \*C15.10. and \*C15.11. Chapter 16. AMENDMENTS

\*C16.01., \*C16.02., \*C16.03. and \*C16.04. Chapter 17. BYLAWS \*C17.01., \*C17.02., \*C17.03. and \*C17.04. Chapter 18. CONTINUING RESOLUTIONS \*C18.01. and \*C18.02. Chapter 19. INDEMNIFICATION \*C19.01. Chapter 20. PARISH AUTHORIZATION (Required only for a congregation that is part of a parish) \*C20.01., \*C20.02., \*C20.03., \*C20.04., \*C20.05. and \*C20.06.

According to the ELCA constitution these provisions need to be adopted by all congregations who wish to be members of the ELCA.

Normally changes to a congregation's constitution require 2 approving votes by the congregation with the 2<sup>nd</sup> vote passing by a 2/3 majority before a change is officially adopted. However there are specific rules in Emanuel's constitution that make it easier to adopt changes that come from the ELCA's model constitution. Only 1 vote passing by a simple majority is required.

Every 3 years there is a churchwide assembly of the ELCA. All the synods from across the country send representatives to the churchwide assembly including the New England Synod, which Emanuel is a part of.

Sometimes at the churchwide assembly changes are proposed to the ELCA model constitution. Sometimes the changes are substantial. Sometimes they are small corrections. If the proposed changes are approved, then the ELCA model constitution is updated and all member congregations of the ELCA need to vote on adopting the changes.

It has been many years since Emanuel has incorporated ELCA model constitution changes into our constitution. We hope to do that this year. There will be a special congregational meeting on **Sunday November 6<sup>th</sup>** after worship to vote on adopting all the required updates from the ELCA model constitution into Emanuel's constitution.

#### **Upcoming Commemorations**

#### James of Jerusalem, martyr, died around 62 Sunday, October 23, 2022

One of three early-church leaders named James, this man is identified in the New Testament and by a historian of the time as a brother of Jesus. Scholars are uncertain whether this means a blood brother. He was a leader of the church in Jerusalem.

# Philipp Nicolai, died 1608; Johann Heermann, died 1647; Paul Gerhardt, died 1676; hymnwriters

#### Wednesday, October 26, 2022

These great hymnwriters all worked in seventeenth-century Germany in times of war and plague. Nicolai, a pastor, lost 1,300 parishioners to plague, 170 in one week. He wrote "O Morning Star, how fair and bright" and "Wake, awake, for night is flying." Heermann's hymns, including "Ah, holy Jesus," often express the emotions of faith. Gerhardt, perhaps the greatest Lutheran hymnwriter, was a pastor in Berlin.

#### Simon and Jude, Apostles Friday, October 28, 2022

We know little about these apostles. Simon is listed as "the zealot" or Cananean in New Testament lists. Jude, also called Thaddeus, asked Jesus at the last supper why he had revealed himself to the disciples but not to the world.
